



# HELP WANTED

Band conditions got you down? Those new finals go flat already? Someone called you "good buddy" on simplex today? (Oh well.) Let me suggest a new activity guaranteed to bring back that old ham fever. Here's the pitch . . . How about helping to conduct one of our future novice license classes???

If you hold the General, Advanced, or Extra ticket, you are certainly qualified to conduct a novice class for our club. Don't worry about the curriculum; the ARRL backs you up 100% with lesson plans, handouts, sample tests - the whole magilla. Or you may have your own ideas on conducting a class; please feel free to implement them.

Now don't let personal inexperience be a deterrent. The ARRL says that the vast majority of volunteer instructors have no formal training or background in classroom techniques. All that's really important is the basic knowledge you already possess and the desire to help our fledgling amateurs.

Here's the scenario as I see it - - ARRL-suggested material is recommended as a home-study course. The students provide their own basic text and code practice materials; you supplement this during once-a-week informal get-togethers. It's easy: send a little 5-wpm code; listen to and comment on a variety of cw fists; clear up minor questions in the study of elementary electronics, FCC rules and regulations, and good operating procedures. Honestly, guys, if I can do it, anyone can.

So how about it, fellow club members? The prospective novices are out there just waiting to be invited into this great hobby of ours. They need your guidance and encouragement in order to qualify; most will not make the novice level without the type of planned activity and group participation that we can offer if we maintain a reservior of volunteer instructors. If you can donate one evening a week to help with novice code practice or theory presentation, please call Fried (549-8516), Nate (545-1298) or Rick (847-1864). MINUTES OF THE OCARD MEETING ON MAY 20, 1977

- o Meeting begun at 7:45.
- o A motion was approved and seconded to adopt minutes of the last meeting.
- o Jim Kingsbury gives the introduction of the guest speaker, Don Royer. Don is a radio manateur (WA6PIR), a lawyer (patent law), is on the board of the Personal Communications Foundation, and is speaking on present and future law reguarding amateurs.
  - There are going to be about 7000 lawsuits over interference and antennas this year. There were 25 ten years ago.
  - . Cities can impose restrictions. The courts say the restrictions must be resonable. A fifty or sixty foot antenna is resonable acording to the court, not thirty feet.
  - . The laws are not being enforced and applied equally in all areas.
  - . Seven in ten people are within 500 ft. of an amaetur/CB antenna. This was one in 20,000 several years ago. We all live in RF fields.
  - . There is nothing you can do about CC&R's.
  - . When you buy a home or rent an apartment you must find out the CC&R's and any restrictions on the property.

# Things to do:

- Clean up your own station. Get the proper filters, supress harmonics. (Out of sight, out of mind).
- . Talk to your neighbors. Boost public relations. Get the ARRL RFI packet.
- . Watch the city in which you live. They sneak in ordinances.
- . Participate in group efforts. Numbers count, bring your children. Don't be afraid of fighting city hall.
- . If your city requires a permit for an antenna, get it. Your home owners insurance may not cover the antenna if it falls if you do not have a permit for it.

- . Wayne, K6RQD, mentioned the need to write State Senator John Briggs about the Senate Bill 915 and urge its defeat.
- . The novice class instructors are present.

ATTENTION SIX METER OPERATORS. THE LONG AWAITED FRENCH 50 MHZ BEACON IS NOW ON THE AIR. IT IS IN CONTINUOUS OPERATION ON A FREQUENCY JUST BELOW 50.1 MHZ AND IS EXPECTED TO REMAIN ON AT LEAST THROUGH THE SUMMER SPORADIC E SEASON. JUDGING BY SUMMER EXPERIENCE ON 28 MHZ THE MOST LIKELY PERIOD FOR HEARING IT WOULD BE THE MORNING HOURS EASTERN TIME, THOUGH LISTENING AT ANY HOUR IS ENCOURAGED. PLEASE RUSH DETAILS OF ANY SUCCESS IN RECEIVING THE SIGNAL TO ARRL, ATTENTION OF W1HDQ. NEGATIVE REPORTS ARE ALSO USEFUL. ALL DETAILS WILL BE FORWARDED TO F9SH, SPORADIC E COORDINATOR FOR IARU REGION 1.

HR PROPAGATION FORECAST BULLETIN NR 39 FROM ARRL HEADQUARTERS
NEWINGTON CT MAY 31, 1977
TO ALL RADIO AMATEURS

POOR CONDITIONS FORECAST FOR THE PERIOD MAY 27 TO 30 FAILED TO MATERIALIZE, DEMONSTRATING A FACT OFTEN STATED IN THESE BULLETINS. MOST EVENTS IN THE NEW SOLAR CYCLE ARE SHORT LIVED, SO LONG TERM PREDICTIONS BASED ON RECURRING EFFECTS ARE NOT TOO RELIABLE. DETAILED AND FREQUENT OBSERVATION OF THE SUN IS NECESSARY.

A LARGE NEW ACTIVE AREA DEVELOPED NEAR THE CENTRAL MERIDIAN OF THE SUN MAY 29. FROM A MAY LOW OF 75 ON THE 27TH, THE FLUX ROSE TO 85 MAY 30. THIS LARGE INCREASE ALMOST CERTAINLY PRESAGES A PREVIOUSLY UNPREDICTED DISTURBED PERIOD, PROBABLY BEGINNING JUNE 1. THE EXTENSIVE PERIOD OF SHORT SKIP OF THE E LAYER VARIETY ON 21 MHZ AND MANY OTHER FREQUENCIES MAY 29 TO 31 MAY HAVE BEEN A PRELUDE TO THIS. A RETURN TO QUIETER GEOMAGNETIC E CONDITIONS AND BETTER PROPAGATION ON THE LOWER HF BANDS IS EXPECTED FOR THE BALANCE OF THE FORECAST WEEK. NEW BULLETINS WILL BE ISSUED ANY DAY WHEN NEW INFORMATION IS AVAILABLE.
